Used as fat powder in food applications with additional nutritional benefit, e.g. sports food, weight management, snack food.

Composition

Ingredients in descending order of weight: Medium-chain triglycerides, glucose syrup, milk proteins, citric acid esters of mono- and diglycerides of fatty acids (E 472c).

All additives used in Delios® V Powder comply with the current specifications established by the Joint FAO/WHO Expert Committee on Food Additives (JECFA) and the current EU Regulation laying down specifications for food additives.

The product should be stored at temperatures below 25 °C, in a dry place. Keep away from odor intensive products.
