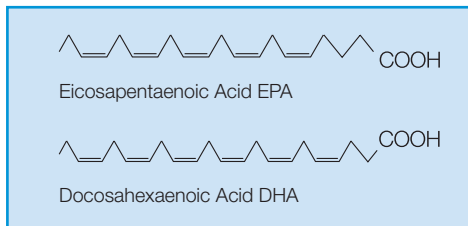

Description

Bursts 1812 Lemon is a food (dietary) supplement in the form of a chewable soft gelatin capsule containing refined fish oil as a source of omega-3 fatty acids.

Composition

Ingredients in descending order of weight:
Fish oil, glycerol (E 422), bovine gelatin, vegetable fats (shea, coconut), modified starches (E 1404 & E 1420), mannitol (E 421), flavourings, beeswax yellow (E 901), citric acid (E 330), lemon juice on maltodextrin, sunflower lecithin (E 322), extracts of rosemary (E 392), sucralose (E 955), iron oxides (E 172), copper chlorophyllin (E 141).

Monographs and Regulations

The fish oil used in Bursts 1812 Lemon conforms to the voluntary GOED monograph and the EU regulation 1881/2006, as amended for heavy metals, dioxins (PCDDs/ PCDFs), dioxins-like PCBs, non-dioxin-like PCBs and polycyclic aromatic hydrocarbons (PAHs).

Stability, Storage and Handling

The bulk capsule carton packaging is not intended for long-term storage.

It is recommended to repack the capsules within 3 – 4 weeks of receipt.

Stored in its unopened original packaging at the indicated storage conditions, the product is stable for at least 6 months.

Store at 15 – 25 °C (59 – 77 °F) and not more than 65% relative humidity. Protect from freezing, heat, light, and humidity.

Applications

Bursts 1812 Lemon is a food supplement (dietary supplement) intended for the general population (not for children younger than 3 years of age). The recommended dosage is 1 – 2 capsules per day dependent on the age group.
