Description

Vegapure® 67 WDP is a mixture of plant sterol fatty acid esters spray dried into a water dispersible powder. The phytosterol esters are obtained by esterification of free plant sterols with fatty acids obtained from vegetable oil. The carrier system consists of a mixture of sodium caseinate and glucose syrup

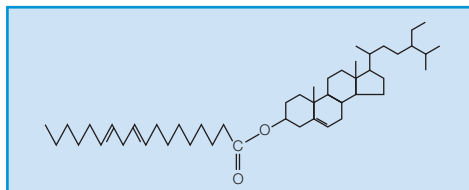
Composition

Ingredients in descending order of weight: plant sterol esters*, sodium caseinate, glucose syrup, silicon dioxide (E 551), sodium ascorbate (E 301), tocopherol-rich extract* (E 306), ascorbyl palmitate (E 304).

* mainly derived from soybean

Water dispersible; insoluble in organic solvents, vegetable oils and fats.

The ingredient plant sterol ester in Vegapure® 67 WDP complies with the FAO JECFA Monograph PHYTOSTEROLS, PHYTOSTANOLS AND THEIR ESTERS.

Standards

Product is kosher and halal. Produced under ISO 9001, FSSC 22000.

Regulations

Plant sterol esters have GRAS (generally recognized as safe) status for use in food applications in the USA. Plant sterol esters are accepted for use in foods and in dietary supplements in most countries. However, specific regulations on the product and its ingredients in the respective countries and for its intended use have to be observed. Vegapure® 67 WDP is derived from genetically modified vegetable and is thus subject to labeling under the Regulations (EC) No. 1829/2003 and 1830/2003 (the product is PCR negative).

Stability, Storage and Handling

For food applications: stored in its unopened original packaging at refrigerated conditions (4 – 8 °C for maintaining the fresh taste), the product is stable for at least 15 months.

For dietary supplements: in hard shell capsules or similar applications where sensory is not as important as in food products Vegapure® 67 WDP will keep at least for 24 months stored under ambient conditions (below 25 °C).

The product is sensitive to atmospheric oxygen, light and heat. It should therefore be stored in the tightly sealed, lightproof packaging in a cool place. Once opened, it is recommended to use the remaining contents as quickly as possible.

Applications

Food:

Vegapure® 67 WDP is intended for use in functional food/functional dairy products. It is almost neutral in taste and odor and is an ideal form for plant sterols in food applications.

Dietary supplements:

Vegapure® 67 WDP is also intended for use in supplements selected applications are hard shell capsules, pH neutral instant powder mixes or nutrition bars. It is not recommended for use in tablets because it will not withstand the pressure applied during high-speed tableting.
